MOVE is an eco-revolutionary group dedicated to liberation struggles.

Eric McDavid was arrested and charged with "Conspiracy to damage and destroy property by fire and and explosive." His arrest was the direct result of a government informant - known only as "Anna" - who spent a year and a half drawing him in and working with the FBI to fabricate a crime and implicate Eric in it. Eric was imprisoned for what amounts to thought-crime - no actions were ever carried out.

Veteran New York criminal defense attorney Lynne Stewart was sentenced to 10 years in prison for the crime of defending a terrorist too vigorously in court. She was convicted of "providing material support to the Gama'a Islamiya", which was on the Bush administration's list of terrorist organizations. "Whatever I did, I did as a lawyer. It's nothing different than I have done for 20 years." She is dying of cancer while imprisoned. There is a campaign to get her released to get the treatment she needs.

Herman and two others began a prison chapter of the Black Panther Party in 1971. The men then organized prisoners to build a movement within the walls to desegregate the prison, to end systematic rape and violence, for better living conditions, and worked as jailhouse lawyers helping prisoners file legal papers. They organized multiple strikes and sit-ins for better conditions. Herman has been held in solitary confinement for the past 41 years. He was recently given two months to live. 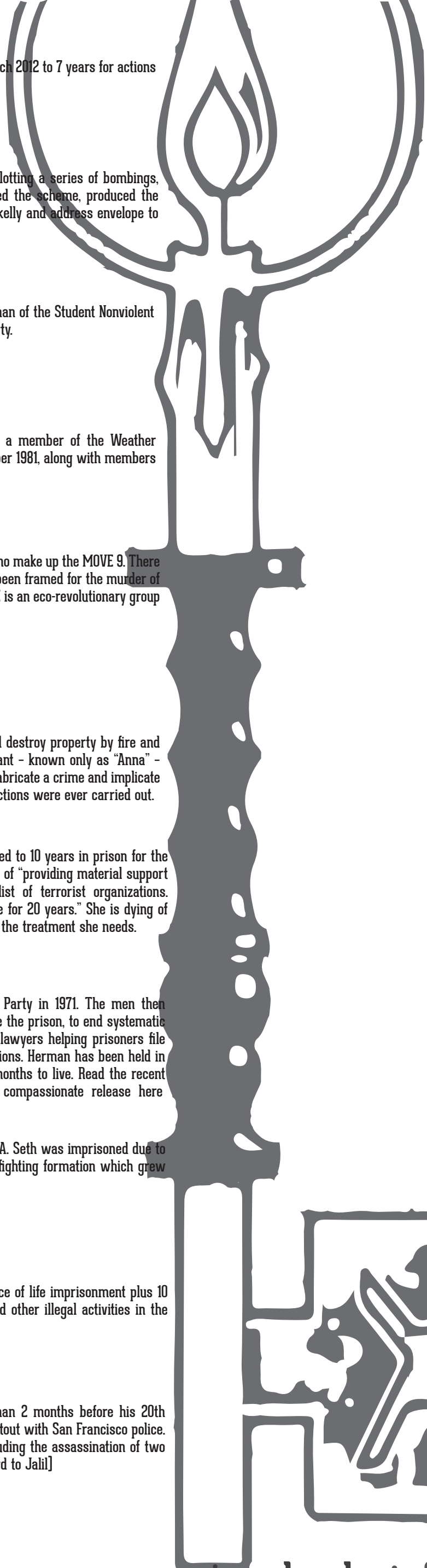
